PURPOSE AND JUSTIFICATION:

To see if the Town Council will vote to amend the North Attleborough Bylaws Chapter 108, Animals, Section 108-3(E), Kennel Licenses.

Amend annual fee to: The annual fee of \$50.00 for four (4) dogs or less or \$100.00 for more than four (4) dogs for the license period hereinabove. Commercial kennel license annual fee \$200.00 for the license period hereinabove.

108-3 (C2): Dog owners over the age of 70, 1 free dog license per household.

Purpose and Justification:

Kennel licenses. See MGL c. 140 § 137A, and inspections, MGL c. 140 § 137C. This subsection shall include commercial boarding or training kennels issued by the Town Clerk and the annual fee of \$50.00 for 4 dogs or less of \$100.00 for more than 4 dogs for the license period hereinabove. Commercial kennel license annual fee \$200.00 for the license period hereinabove. Such kennel license shall be in a form established by the Town Clerk and shall be subject to conditions and requirements established in the Town General and Zoning Bylaws.
