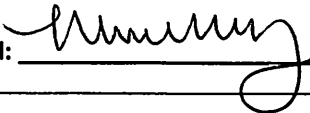

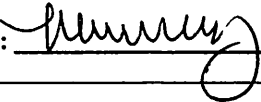

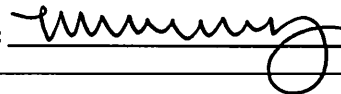

PURPOSE AND JUSTIFICATION:

The Master Plan cost to the Town is \$40,000. Town Council previously funded \$20,000 for the Master Plan in Measure 2022-089. This measure is to request to reappropriate \$19,800 from Measure 2022-051- Land Use Planning \$110,000 (MUNIS 30175251-530007) to fund the remaining balance of the Master Plan.

The Town of North Attleborough was awarded a \$110K grant for the Stantec projects from the Community Planning & Housing Choice Program by the Department of Housing and Community Development. This grant is now funding the remainder of the projects from the RFP with Stantec.

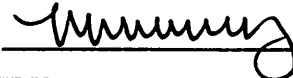

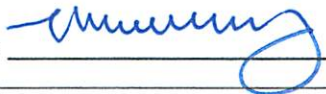

 22 AUG 22**PURPOSE AND JUSTIFICATION:**

The purpose of this measure is to consider creating a bylaw that would establish the process and procedures by which a street, bridge, or other public area can be memorialized or dedicated by the Town through the Town Council. The intent of this bylaw is not to replace the process or procedure that exists in the Planning Board for subdivision street naming.

This bylaw would include the following:

1. Process by which an individual or entity can submit to the Town a street, bridge, or other public place a recommendation for memorialization or dedication.
2. Identification and notification of abutters must be identified for any road, street, way, or bridge.
3. The submitted recommendation would include a first choice name and a second choice name.
4. Recommended names and name changes must be submitted to Fire Department for written approval of the names chosen and their sign-off on the form.
5. Requesting party must contact all abutters to get their concurrence. Acceptance by a two-thirds majority of the abutters, as identified by the Assessor's Office, would be needed to proceed with the name change.
6. Determination of the appropriate fee involved with this request. Included in any dedication or name change is the cost of signage and installation related to such signage.

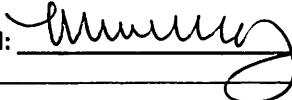

PURPOSE AND JUSTIFICATION: Continued: 7. Requesting party would submit the completed abutter sign-off forms, the name change form, and a certified list of abutters to the Town Council for consideration at time of the Town Council's choosing. The Town Council would schedule a public hearing for the requested name change and notify the applicant and the abutters. 8. Hold a public hearing on the proposed memorialization and/or road name change. 9. Town Council, by majority vote, makes an order to change the name of the road. The new name will be included in the measure. The Clerk of Council will then file a copy of this order with the Bristol County Registry of Deeds/Land Court. 10. Once approved, public safety will be notified of the name change. 11. Following the memorialization, name change approval, DPW will be directed to install the appropriate street signs specifying the new name at or near each point where the road joins another road or way. In the case of a private road, abutters pay for the sign, but the DPW can install it.

PURPOSE AND JUSTIFICATION:

Verizon bills our long distance calls separately from our standard voice calls. While investigating a billing issue with our accounting department, we needed to create an online account per Verizon to research the issue at hand. By creating the online presence, Verizon changed our billing to paperless billing by default which was not obvious at the time.

Our long distance bill is not very large and it was not noticed we were not getting the usual paper bill. Several months ago, we received a past due letter from Verizon. After many calls to Verizon and several representatives later, we determined the issue and we were not sent paper invoices since around May of 2020.

This lines up with the last payment of April of 2020 to this particular line. The attached spreadsheet has each month and dollar amount to be paid.
