The purpose of this Measure is to authorize the transfer of \$50,000.00 from the Town's Reserve Fund Line Item to support increased Legal Service Expenses that the Town has incurred over the past few months.

Therefore, the Town Manager is requesting Authorization to Transfer Funds in the amount of \$50,000.00 to the K.P. Law Legal Services Account 011519-530003 from Town's Reserve Fund 011329-578000

Town Manager Borg reviewed this measure with the Committee. He went over each of the line items and the costs associated with them. The Brady vs. Town litigation in the amount of \$46,000.00 was the major portion of the expenses. As of now, Brady owes the Town \$65,000.00, and we are hoping for one more judgement for damages.

Councilor Gould was in support of transferring these funds.

Councilor Gould asked if the Town Council could get a brief update on all Legal Cases that are pending.

Councilor Simmons stated that the Town Council may already do this annually, and he will check with the Council President to see when this is scheduled for. This discussion may need to be in Executive Session.

St. Pierre made a motion to refer measure 2026-044 back to the Full Town Council and recommend positive action.
