There are 150 miles of roads in town. All roads were swept twice (Fall and Spring) for a total of 300 miles.

Dry weather outfall sampling was performed at 29 outfalls that were designating to be flowing during dry weather screenings. A report, dated April 1, 2023, from the town's consulting engineer is attached.
