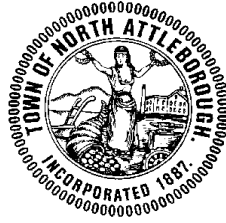

Below are key activities, that I think would be of interest.

### **PUBLIC HEALTH – Updates**

- **COVID-19 Response:**
  - Here is a breakdown of our activities over the past three weeks:
  - Current number of total positives in North Attleborough: **3089**
  - Current number of active infectious cases: **40**
  - Cases last week: **50**
  - Cases for the month of September: **177**
  - We are considered a “high” community transmission according to the CDC definition. If there are over 30 cases, the community is considered high.
  - Current positivity rate: **2.9%**

- Town Manager & Assistant Town Manager met with Tri-County Superintendent Karen Maguire

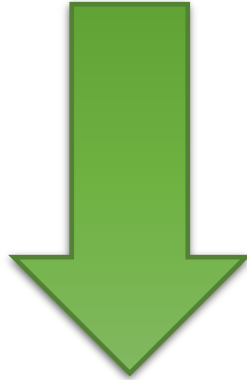

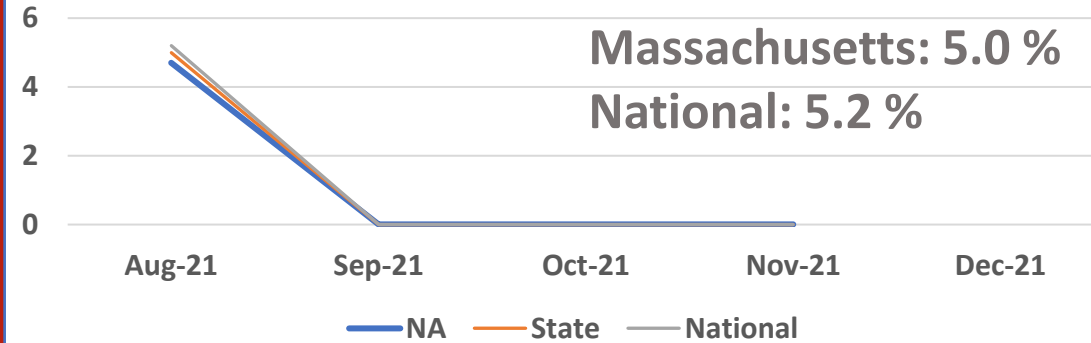

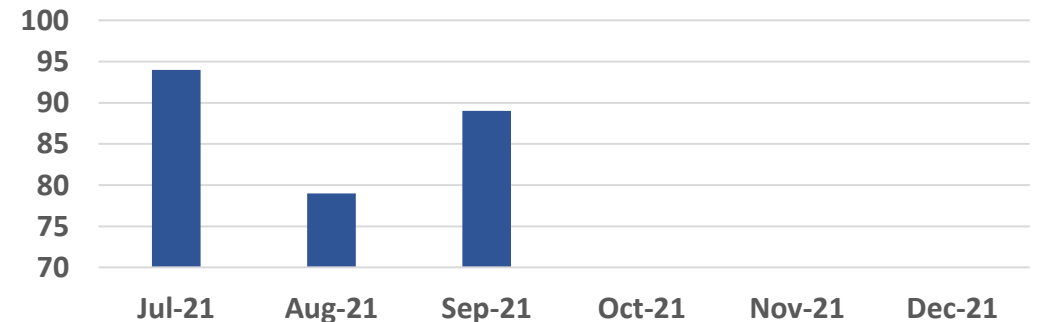
