

Town of North Attleborough, Massachusetts



On Monday, January 22 at 6:30 PM, the North Attleboro Planning Board will hold a public hearing on proposed zoning changes to prohibit in all residential and commercial zones establishments selling motor vehicles and/or motor vehicle accessories and boats as well as establishments selling used motor vehicles requiring a Class II License.

To see if the Town will vote to amend its Zoning Bylaws, Table of Use Regulations Schedule B by prohibiting the following uses in all zoning districts: Retail and Service number 5. Establishments selling motor vehicles and/or motor vehicle accessories and boats and Retail and Service number 5b. Establishments selling used motor vehicles requiring a Class II License. The full text of these proposed amendments can be viewed online on the Planning Board website under Legal Ads and Hearing Packets or under the Town's calendar on January 22. It can also be viewed at the Planning Department in Town Hall.
