RE: **Measure 2024-014-authorization to transfer and repurpose \$1,398.00 from FY23 Capital Improvement Project- Fire Head Quarter's Furnace Replacement (Free Cash) to supplement the purchase of Two Town Vehicles originally funded in the amount of \$60,000.00 (Free Cash).**

Measure 2024-014-authorization to transfer and repurpose \$1,398.00 from FY23 Capital Improvement Project- Fire Head Quarter's Furnace Replacement (Free Cash) to supplement the purchase of Two Town Vehicles originally funded in the amount of \$60,000.00 (Free Cash).

Purpose and Justification:

Measure 2021-065 provided for a vehicle replacement for Two Town Vehicles totaling \$60,000.00. Earlier this month, the Town issued an RFP for the two vehicles. The Town received one response to the RFP for two vehicles with a total price of \$61,398.00. The outstanding balance of \$1,398.00 will need to be funded.

Measure 2022-082 provided for a Fire Department Head Quarters Furnace Replacement in the amount of \$60,000.00. The furnace was replaced and there is currently a left over balance of \$1,500.00 in the account.

Therefore, I respectfully request the Town Council vote to approve a transfer in the amount of \$1,398.00 from the Measure 2022-082- Fire Head Quarters Furnace Replacement, Account # 30220082-582040 to fund the remaining balance for the purchase of Two Town Vehicles.

The Town Council met on August 28, 2023, and on behalf of the Town Council, a motion was made by Vice-President Simmons to approve Measure 2024-014- Authorization to transfer and repurpose \$1,398.00 from FY23 Capital Improvement Project- Fire Head Quarter's Furnace Replacement (Free Cash) to supplement the purchase of Two Town Vehicles originally funded in the amount of \$60,000.00 (Free Cash).

The motion was seconded by Councilor Slobogan.

A roll call vote was taken; Councilor St. Pierre-Yes, Councilor Costello-Yes, Councilor Gould-Yes, Councilor Gregory-Yes, Vice-President Simmons-Yes, President Pare³-Yes, Councilor Slobogan - Yes, Councilor Donovan-Yes, and Councilor Shanahan-Yes.

Motion carried. 9-0 UNANIMOUS
