**PURPOSE AND JUSTIFICATION:**

The procurement of the Big Red Bus is complete. We would like to protect this bus from the elements and the best way would be to treat the undercarriage of the bus, and provide housing for the bus when not in use. The following is being requested to keep the bus in the best possible condition:

- 1. \$4,000 to spray protectant on undercarriage the bus
- 2. \$10,000 for a carport to house the bus
- 3. \$4,000 for gravel and reclaim to create the parking area

In Measure 2023-032- Request for a Transfer from FY23 Free Cash in the amount of \$115,000.00 for the purchase of a Big Red Bus for the Town of North Attleborough, there is currently a balance of \$45,764.00 left in this account. **PURPOSE AND JUSTIFICATION:**

Request for a Transfer from FY23 Free Cash for the purchase of a Big Red Bus for the Town of North Attleboro

Town of North Attleboro received a grant in the amount of \$50,000.00 from the Massachusetts Department of Transportation from State Representative Adam Scanlon's Office. \$50,000 was appropriated to help purchase a bus for the community. The cost of a 2022 twenty-two passenger bus with wheelchair capability is \$155,00.00 delivered to North Attleboro (this includes approximately \$10,000 to wrap it). The grant funds need to be sent by June of this year.
