To: North Attleboro Town Council,

Attached please find a citizen's petition, executed by greater than 25 citizens/voters, directing the Town Council to grant a FY 26 Real Estate Tax reduction to taxpaying citizens in the amount of \$1.7M.

Petition as submitted includes each voters' Printed Name, Printed Address and Signature, as requested by the Town Council, despite conflicting language in Section 8-1 of the current North Attleboro Town Charter which states "petition shall not be required to take any particular form, is signed by no less than 25 voters". Please note language requiring a voter's Printed Name and Printed Address is absent and does not appear anywhere in Section 8-1 of the current Town Charter.

Therefore, petitioners also direct the Town Council to cause amendment of Section 8-1 of the current Town Charter such that the language of Section 8-1 of the North Attleboro Town Charter accurately reflect the requirements (with specificity) regarding the completion/submission of a citizen's petition.

The reason for this hearing is to formally request that the North Attleboro Town Council vote "in favor" of granting a Real Estate Tax reduction for FY26, in the amount of \$1,700,000, for the benefit of North Attleboro residents. Further, the requested Real Estate Tax reduction of \$1,700,000 approximates the amount of Real Estate Tax, included in the FY26 Annual Budget, identified as a Proposition 2 ½ assessment/tax levy.
